Iris came to Good Samaritan under very difficult circumstances during the Christmas season, and the staff team immediately noticed her during the registration and orientation process for new patients. At that time, she was pregnant, she had no nearby family, no job, and her husband was detained in Macon, Georgia. She was without hope. However, as she gained familiarity with the staff team, she realized that she was more than just a patient. She recognized that there was "more to Good Sam than just medical care".

During this season of turmoil, Iris had been praying. If there is a God, she wanted to know Him. If faith in Christ is real, she wanted to experience Him. Through the Angel Tree Program, Good Sam's staff provided gifts and other services to assist in her preparations for the birth of their new son. After little "Angel" was born, the staff Chaplain, Pastor David Santander, and his wife, Leanne, then assisted in finding more suitable housing and transportation arrangements for this growing family. These tangible reminders of the love of Christ provided providential opportunities

to share the message of the Gospel. Iris indeed received Jesus as her Lord and Savior.

As so often occurs with divine providence, Iris' husband, Jose, was also actively searching the Scripture and seeking the Lord during his painful separation from their growing family. Independently of Iris, he too had placed his faith in Christ, and was actively praying daily for the well-being of his family. As a new Believer, his faith in God was likewise being encouraged as he began hearing about these new "friends" who were assisting Iris during his absence.

After the family soon joyously reunited here in Marietta, they began attending Johnson Ferry Baptist Church where they were baptized together and are now actively serving as lay leaders within the Spanish congregation. Iris and her family are a flourishing part of this community. Jose has now started his own construction business, and they are actively sharing the message of Christ's amazing love, His mercy, and His restoration.

# MEDICAL DEPARTMENT

The medical department at Good
Samaritan serves as an interdisciplinary
team and medical home for patients of all
backgrounds. The rich diversity of our patient
population, coupled with the expertise of our
counselors, physicians, nurse practitioners,
and specialists, allows the clinic to serve
as a true medical home within Cobb County.
No matter the condition or background of
our patients, the team readily embraces
each individual openly as the Samaritan
cared for the injured Jewish man in Luke 10.

"I came to Good Samaritan seeking care for my abdominal pain, and received far more. My medical provider, Ryan, ordered an abdominal ultrasound for me and performed a thorough exam. At the end of the visit, he also prayed for me. He prayed and cared for me as an individual valued by God. He shared how Jesus had died for me and rose from the dead, and is the great healer. Not only was this clinic a place for medical care, it was beginning to feel like my own home. It was like I was in church, but also in a clinic. I went home with renewed faith, and soon found my pain completely improved. I talked with my wife, and we decided I should still go to the ultrasound. It was completely normal. I am confident Jesus healed me that day, and we are so thankful to Good Samaritan for being a place where I could encounter Him."




# DENTAL DEPARTMENT

The Dental Department of Good Samaritan Health Center of Cobb is a comprehensive dental clinic serving the health and the heart of our patients on EVERY level. We perform all preventative services and aesthetic dental procedures, such as composite fillings, crowns and bridges, as well as most elective procedures.

"Life events put me in a place where I needed hope, and I ended up finding it at Good Samaritan. My main concern about seeing a dentist was that the treatment would keep me from being able to work, as I'm a voiceover artist. I was extremely afraid. Dr. Smith, Juneia, and Jordan from the staff were top notch on all levels and very professional. They were so understanding and supportive. ## **DISPENSARY DEPARTMENT**

Good Samaritan's dispensary continues to grow and serve the surrounding community. In 2023, more than 10,632 patients visited our dispensary window to obtain medications at a reduced cost through our participation in the 340B program. Additionally, 1,033 prescriptions were filled through our Patient Assistance Program (PAP) and we dispensed 940 vaccines. Furthermore, the dispensary team created a diabetes self-management education and support (DSMES) program for those patients diagnosed with diabetes. The team enrolled more than 35 patients.

Finally, one of our bigger and more visible changes in 2023 was the move to our new dispensary space. The new space has a designated area for patient education, counseling, and vaccine administration. We are very thankful for the many supporters who have enabled us to add these incredibly valuable services for our patients.

"Isabella had difficulty adjusting to a recent move, the grief from the loss of her grandmother, and the ongoing marital issues with her husband. She was experiencing elevated levels of stress and anxiety as well as moderate depression. With Solution Focused Therapy, she was finally able to create implementable behavioral modification plans and strategies. She received numerous community resources as well as a referral partner to provide couples therapy. Additionally, she learned healthy therapeutic skills and tools for coping with grief, depression, and anxiety." - Dr. Alisha Rorer


- 145 patients were seen in the Behavioral Health department for individual therapy.
- 55 brief interventions were done in the medical clinic during visits with their primary care physician.
- 11 classes were provided with topics including anxiety management, insomnia treatment, trauma awareness, and a 5-week class on smoking cessation.




## **HEALTH EDUCATION**




